To participate, you'll need to work directly with a solar garden operator. The solar garden you subscribe to will manage your participation and gather the paperwork required for you to participate. 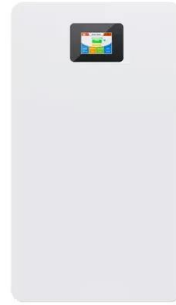
