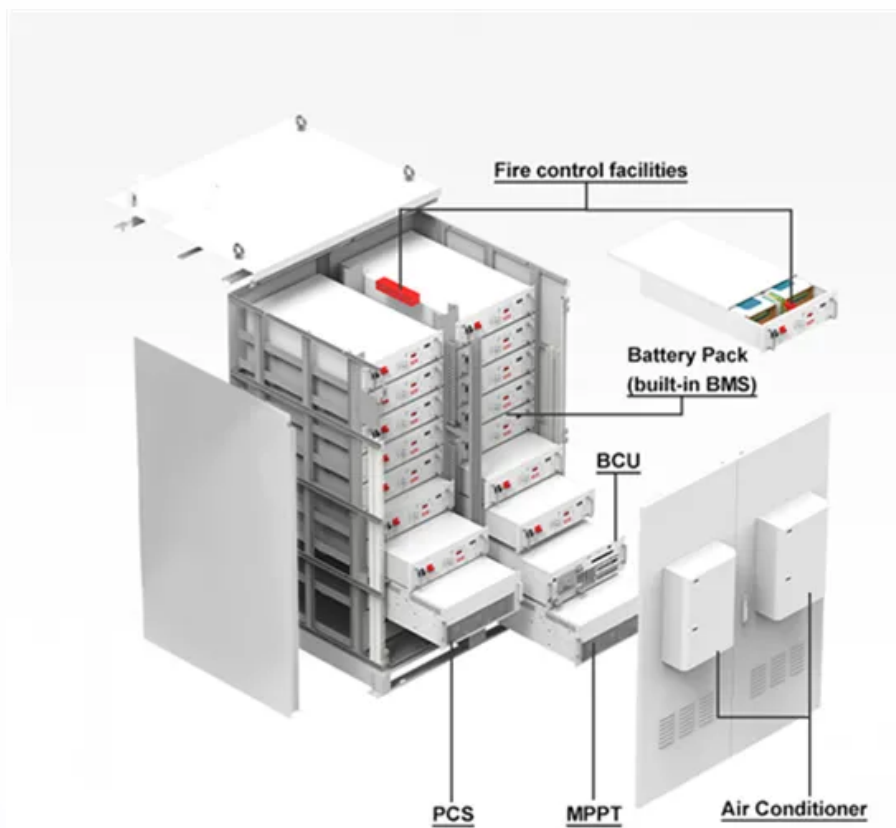


# Xcel energy renewable plan

Does Xcel Energy have a baseline?

Xcel Energy has consistently measured its emissions reduction progress



compared to a 2005 baseline, which is the first year we began measuring and tracking our greenhouse gas emissions. National and international standards commonly use a 2005 baseline as well.

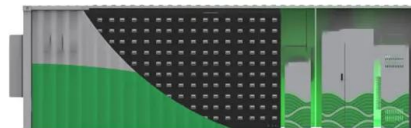
